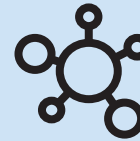

Research and consultancy

Businesses can access research through contract research, PhD or Master's studentships, and government-funded *Knowledge Transfer Partnership* (KTP) projects, as well as other grants schemes that can cover business costs. Our academics can also act as consultants for your business, to help solve business challenges and provide deeper knowledge and insight into a particular topic. Consultancy projects can last for as little as a day or two or for longer periods.

Seedcorn funding

The University also offers Seedcorn funding to support innovative projects undertaken by academics in partnership with a business or organisation. Through the scheme, you could gain access to valuable academic expertise, research, facilities or equipment that could help progress a business idea, address a challenge and potentially lead to further funding. Awards are granted through a competitive application process.

Knowledge Transfer Partnerships (KTP)

KTPs are partially government-funded. They enable businesses to harness the expert knowledge, technology and research of universities to help improve their processes and products via innovative projects. If you face a strategic challenge which is central to the development of your business, a KTP could offer a solution. Businesses typically achieve significantly increased growth in turnover and profitability, as well as the creation of new jobs, following participation in a KTP.

Higher and degree apprenticeships

Higher and degree apprenticeships are designed in partnership with employers to ensure that learners develop skills and knowledge relevant to your business needs. Funding is generated through the apprenticeship levy and allows larger employers to use their contribution to pay for professional training within their organisation. Higher and degree apprenticeships are available to SMEs by co-investment.

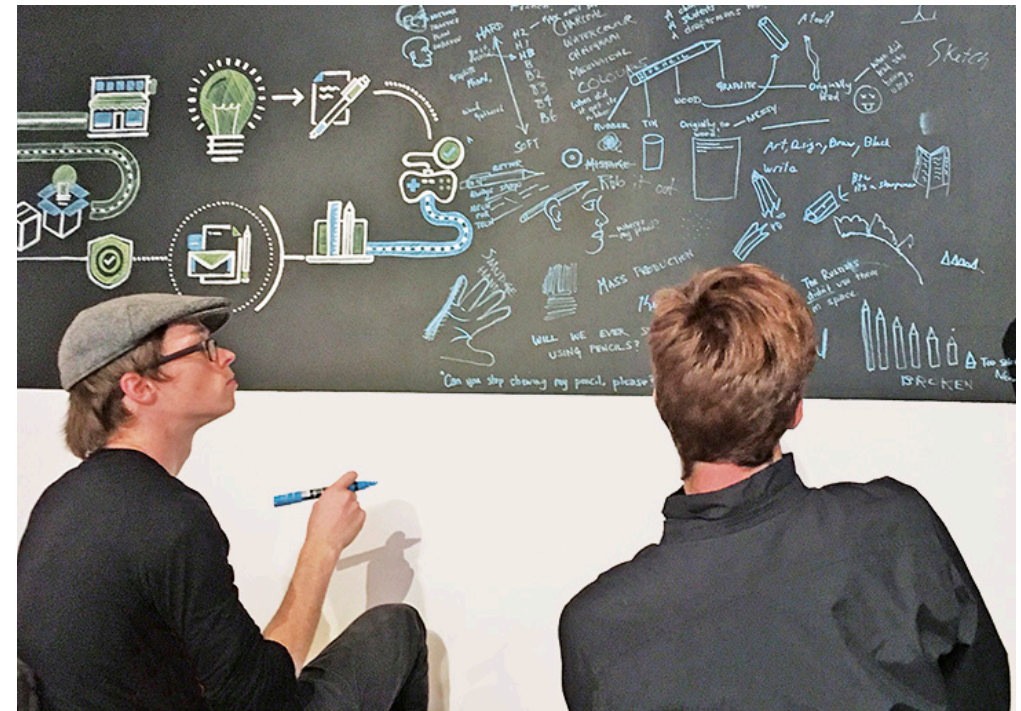
Student mentoring, sponsorship and corporate social responsibility (CSR) opportunities
